This Online Privacy Policy (the "Privacy Policy") applies to iCOR Medical online interface, i.e., website, mobile applications, electronic services, and social networking sites (collectively, the "Site") owned and operated by iCOR Medical, LLC. ("iCOR" or "Company"), and any Company affiliate or subsidiary online interface that links to this Privacy Policy.

YOUR PRIVACY IS IMPORTANT TO US. PLEASE READ THIS PRIVACY POLICY TO LEARN ABOUT THE INFORMATION THAT WE COLLECT FROM YOU AND HOW WE USE THAT INFORMATION. BY USING THE SERVICES YOU CONSENT TO THE COLLECTION, USE AND TRANSFER OF YOUR PERSONAL DATA AS DESCRIBED IN THIS PRIVACY POLICY. IF YOU DO NOT AGREE WITH ANY PART OF THIS PRIVACY POLICY, THEN PLEASE DO NOT USE THE SERVICES.

PLEASE BE AWARE THAT ICOR AND ALL ASSOCIATED SERVICES AND SYSTEMS ARE HOUSED ON SERVERS IN THE UNITED STATES. IF YOU ARE LOCATED OUTSIDE OF THE UNITED STATES, INFORMATION WE COLLECT (INCLUDING COOKIES) ARE PROCESSED AND STORED IN THE UNITED STATES, WHICH MAY NOT OFFER THE SAME LEVEL OF PRIVACY PROTECTION AS THE COUNTRY WHERE YOU RESIDE OR ARE A CITIZEN. BY USING THE SITE AND PROVIDING INFORMATION TO US, YOU CONSENT TO THE TRANSFER TO AND PROCESSING OF THE INFORMATION IN THE UNITED STATES.

1. SCOPE

This Privacy Policy describes the information that we collect (directly or indirectly) and why we collect it, what we do with the information we collect and how you can manage your personal information. You may download a copy of this <u>Privacy Policy</u>.

This Privacy Policy does not apply to information that is considered "protected health information" (PHI) under the Health Insurance Portability and Accountability Act of 1996 or its implementing regulations (the "HIPAA Rules"). For more information about how we may use and disclose your medical information under the HIPAA Rules, please refer to our NOTICE OF PRIVACY PRACTICES.

Our site may contain links to other sites whose information practices may be different than ours. We do not have control over the information that is submitted to, or collected by, these third parties. You should consult the privacy policy of these other sites to learn how your privacy is protected.

2. INFORMATION WE COLLECT

Personally Identifiable Information You Provide: We collect information that you voluntarily provide when you use our services, such as when you register for our services, participate in a survey, provide a testimonial, participate in an interactive feature or forum (such as chat features), or contact us with a question, comment, or request. This personally identifiable information that you provide might include, for instance, your name, address, age, birth date, gender, email address, phone number, photo, social media account ID, zip code, education, professional experience, demographic information, information about your health and/or medical conditions, product and services usage and preferences.

Non-Personally Identifiable Information We May Collect: Non-Personally Identifiable Information refers to information that does not, in itself, identify a specific individual. We gather certain

information about you based upon the portion(s) of the websites that you visit. This information is compiled and analyzed on both a personal and an aggregated basis. This information may include the website's Uniform Resource Locator ("URL") that you just came from, which URL you go to next, what browser you are using, and your Internet Protocol ("IP") address. A URL is the global address of documents and other resources on the World Wide Web. An IP address is an identifier for a computer or device on a Transmission Control Protocol/Internet Protocol ("TCP/IP") network, such as the World Wide Web ("Web"). Networks like the Web use the TCP/IP protocol to route information based on the IP address of the destination. In other words, an IP address is a number that is automatically assigned to your computer whenever you are surfing the web, allowing web servers to locate and identify your computer. Computers require IP addresses in order for users to communicate on the Internet.

Information We Receive from Third Parties: We may combine the information we collect from you with information that we receive about you from other sources, such as public databases, providers of demographic information, joint marketing partners, social media platforms, people with whom you are connected on social media platforms, and other third parties.

Below are some examples of the personal information we may collect through the Site:

- **Identifiers:** Real name, alias, postal address, unique personal identifier, online identifier, IP address, email address, account name, or other similar identifiers.
- Customer Records: Personal information categories listed in the California Customer Records statute (Cal. Civ. Code § 1798.80(e)), such as name, signature, physical characteristics or description, address, telephone number, passport number, driver's license or state identification card number, insurance policy number, education, employment, employment history, bank account number, credit card number, debit card number, or any other financial information, medical information, or health insurance information. Some personal information included in this category may overlap with other categories.
- Protected Classification Characteristics: Age (40 years or older), race, color, ancestry, national origin, citizenship, religion or creed, marital status, medical condition, physical or mental disability, sex (including gender, gender identity, gender expression, pregnancy or childbirth and related medical conditions), sexual orientation, veteran or military status, genetic information (including familial genetic information).
- **Commercial information:** Records of personal property, products or services purchased, obtained, or considered, or other purchasing or consuming histories or tendencies.
- Internet or other similar network activity: Browsing history, search history, information on a consumer's interaction with a website, application, or advertisement.

We may link together different types of information or link information to personal information. If linked information directly or indirectly identifies an individual person, we treat the linked information as personal information. In this Privacy Policy, to "process" personal information means to perform any operation on personal information, whether or not by automated means, such as collection, recording, organizing, storing, adapting, use, disclosure, combining, erasing or destroying. Where we need to collect personal information by law, or under the terms of the contract between us and you do not provide that data when requested, we may not be able to perform the contract we have or are trying to enter into with you (for example, to provide you with products or Services). In this case, we may have to cancel a product or service you have with us, but we will notify you if this is the case.

3. COLLECTING AND USING INFORMATION

We collect and use information as follows:

- When you register with us or use the Site, you provide us with certain information voluntarily. This may include, your name, mobile or residential phone number, zip code, e-mail address, postal address, date of birth, gender, answers to survey questions and other registration information.
- When you use the Site: We may ask for transaction-related information, such as when you respond to any offers, or download or use applications from us; information you provide us when you contact us; information you enter into our system when using the Site, such as contact information which is clearly labeled at the time you submit it; and information you post on our Site to the extent we permit posting information. We use a third-party payment processor, which is currently Authorize.net to assist with securely processing your payment information. If you pay with a credit card, the payment information that you provide through the Site is encrypted and transmitted directly to Authorize.net. We do not store your payment information and do not control and are not responsible for Authorize.net or its collection or use of your information. - When you make a payment to iCOR: If you make a payment to iCOR, we will ask for payment information and other information requested for processing your payment.
- Through Server Logs: A server log is a list of the activities that a server performs. iCOR's servers automatically collect and store in server logs your Internet addresses, browser type, Internet Service Provider (ISP), referring and exit page, operating system, timestamps, clickstream data,
- From Your Computer, Tablet or Mobile Telephone: the type of mobile device you use, your mobile device's unique device ID, the IP address of your mobile device, and your mobile operating system.
- Cookies and Similar Technologies: Cookies are small text files stored directly on your device. We use cookies to collect information such as time spent on our websites, pages visited, the pages you view immediately before and after you access the website, the search terms you enter, and other anonymous traffic data. Cookies allow us to recognize you and personalize your experience, to facilitate navigation, and to display information more effectively. If you do not want information collected through the use of cookies, most browsers allow you to automatically decline cookies or to be given the choice of declining or accepting cookies from a particular site. We use first-party cookies and third-party cookies together to report ad impressions, other uses of ad services, and interactions with ad impressions related to your visit to our Site. Our Cookies procedure in Section 4 below explains how we use Cookies to collect information about the way you use the Site and how you can control them.

We may collect certain information via third-party analytics services, which may collect your nonsensitive user information. This may include: the information you provide us with, your session ID, your user ID, and conversion data. This information provides us with tools to calculate the numbers and frequency of visitors on the Site and to understand how you and other users use the Site to improve your experience.

We also track and analyze non-identifying and aggregate usage and volume statistical information from our visitors and customers. This information is logged and used for purposes such as to help diagnose technical problems and to administer our Site so that we can constantly

improve it.

4. COOKIES & SIMILAR TECHNOLOGIES

How We Use Cookies

We use Cookies to track how you use the Site by providing usage statistics. Cookies are also used to allow product authentication to you based upon your browsing history and previous visits to the Site. Information supplied to us using cookies helps us to provide a better online experience to our visitors and users and send marketing communications to them, as the case may be. While this information on its own may not constitute your personal information, we may combine the information we collect via Cookies with personal data that we have collected from you to learn more about how you use the Site to improve them.

We treat information collected by cookies and other technologies as non-personal information. However, to the extent that Internet Protocol (IP) addresses or similar identifiers are considered personal information by local law, we also treat these identifiers as personal information. Similarly, to the extent that non-personal information is combined with personal information, we treat the combined information as personal information for the purposes of this Privacy Policy.

Types of Cookies

We use both session cookies (which expire once you close your web browser) and persistent cookies (which stay on your device until you delete them). To make it easier for you to understand why we need them, the Cookies we use on the Site can be grouped into the following categories:

- Strictly Necessary: These Cookies are necessary for the Site to work properly. They include any essential authentication and authorization cookies for the Site.
- Functionality: These Cookies enable technical performance and allow us to "remember" the choices you make while browsing the Site, including any preferences you set. They also include sign-in and authentication cookies and IDs that enable you to return without additional sign-in.
- Performance/Analytics: These Cookies allow us to collect certain information about how you navigate the Site or utilize the Products running on your device. They help us understand which areas you use and what we can do to improve them.
- Marketing and Customer Support: These Cookies are used to deliver relevant information related to the Site to an identified machine or other device (not a named or otherwise identifiable person) which has previously been used to visit the Site. Some of these types of Cookies on the Site are operated by third parties with our permission and are used to identify advertising sources that are effectively driving customers to the Site.

Cookies Set by Third Party Sites

To enhance our content and to deliver a better online experience for our users, we sometimes embed images and videos from other websites on the Site. We currently use and may in future use content from websites such as Facebook, LinkedIn and Twitter. You may be presented with Cookies from these third-party websites. Please note that we do not control these Cookies. The privacy practices of these third parties will be governed by the third parties' own privacy statements or policies. We are not responsible for the security or privacy of any information collected by these third parties, using cookies or other means. You should consult and review the

relevant third-party privacy statement or policy for information on how these cookies are used and how you can control them.

We also use Google, a third-party analytics provider, to collect information about Services usage and the users of the Site, including demographic and interest-level information. Google uses cookies in order to collect demographic and interest-level information and usage information from users that visit the Site, including information about the pages where users enter and exit the Site and what pages users view on the Site, time spent, browser, operating system, and IP address. Cookies allow Google to recognize a user when a user visits the Site and when the user visits other websites. Google uses the information it collects from the Site and other websites to share with us and other website operators' information about users including age range, gender, geographic regions, general interests, and details about devices used to visit websites and purchase items. We do not link information we receive from Google with any of your personal information. Other Similar Technologies

iCOR web pages may use other technologies such as web beacons to help deliver cookies on the Site and count users who have visited those websites. We also may include web beacons in our promotional email or newsletters to determine whether you open and act on them as well as for statistical purposes.

In addition to standard cookies and web beacons, the Site can also use other similar technologies to store and read data files on your computer. This is typically done to maintain your preferences or to improve speed and performance by storing certain files locally.

How to Control and Delete Cookies

Cookies can be controlled, blocked or restricted through your web browser settings. Information on how to do this can be found within the Help section of your browser. All Cookies are browser specific. Therefore, if you use multiple browsers or devices to access websites, you will need to manage your cookie preferences across these environments.

If you are using a mobile device to access the Site, you will need to refer to your instruction manual or other help/settings resource to find out how you can control cookies on your device. Please note: If you restrict, disable or block any or all Cookies from your web browser or mobile or other device, the Site may not operate properly, and you may not have access to the Site available through the Site. iCOR shall not be liable for any impossibility to use the Site or degraded functioning thereof, where such are caused by your settings and choices regarding cookies.

Do Not Track: Some web browsers (including Safari, Internet Explorer, Firefox and Chrome) incorporate a "Do Not Track" ("DNT") or similar feature that signals to websites that a user does not want to have his or her online activity and behavior tracked. 5. HOW WE PROCESS INFORMATION

We will only use your personal data when the law allows us to. Most commonly, we will use your personal data in the following circumstances.

- Where it is necessary for our legitimate interests (or those of a third party), and your interests and fundamental rights do not override those interests.
- Where we need to comply with a legal or regulatory obligation.

We will only use your personal data for the purposes for which we collected it, unless we reasonably consider that we need to use it for another reason and that reason is compatible with the original purpose. If we need to use your personal data for unrelated purposes, we will notify you and we will explain the legal basis which allows us to do so. Please note that we may process your personal data without your knowledge or consent, in compliance with the above rules, where this is required or permitted by law.

iCOR uses your personal information for the following purposes based on our **legitimate** interests

- To communicate with you;
- To administer and protect our business and the Site including troubleshooting, data analysis, security, testing, system maintenance, support, reporting, technical functionality, hosting of data, and in the context of a business reorganization or group restructuring exercise;
- To prevent and investigate fraud and other misuses of the Site;
- To deliver relevant website content and advertisements to you and measure or understand the effectiveness of the advertising we serve to you;
- To use data analytics to improve our website, products/services, marketing, client relationships and experiences; or
- To make suggestions and recommendations to you about products or services that may be of interest to you.

We also use personal information when necessary for the **performance of a contract** in the following contexts:

- To process your payments, orders, and transactions including:
- Manage payments, fees and charges
- Collect and recover money owed to us;
- To set up and maintain your account with us;
- To manage our relationship with you which will include:
- Notifying you about changes to our terms or privacy policy
- Asking you to leave a review or take a survey
- Responding to your questions and inquiries

SMS/Text Message Communications:

iCOR may use the text message-capable number you provide to communicate with you regarding your services, products, or inquiries with iCOR. If you wish to stop receiving text messages, you may UNSUBSCRIBE from any text message sent by us. SMS opt-ins or phone numbers provided for SMS purposes are not shared. This information is used solely for the intended purpose and is not sold, rented, or disclosed to third parties. Mobile Messaging Terms

We may also use your personal data when necessary to **comply with legal obligations.**

6. HOW WE SHARE INFORMATION

We may share information that we collect:

- With our vendors or service providers who help us operate our business such as payment processing, web hosting, or data storage. Additionally, we may share your information with companies that are conducting marketing and advertising to benefit ICOR. These third-party companies may use your contact information for communications and marketing purposes that support our activities. You are under no obligation to respond, and the companies are restricted from using your contact information for any other purpose. iCOR will ensure that any service provider with which we share personal data agrees to safeguard it in substantially the same manner as iCOR has described in this Privacy Policy and in accordance with all applicable laws;
- iCOR may aggregate information collected though the Site and remove identifiers so that the information no longer identifies or can be used to identify an individual ("Anonymized Information"). iCOR shares Anonymized Information with third parties and does not limit third parties' use of the Anonymized Information because it is no longer personal data;
- In response to a subpoena or similar investigative demand, a court order, or a request for cooperation from a law enforcement or other government agency;
- To establish or exercise our legal rights;
- To defend against legal claims;
- When we believe disclosure is necessary to investigate, prevent, or take action regarding illegal activity, suspected fraud or other wrongdoing; to protect and defend the rights, property or safety of our company, our employees, our web site users, or others; or,
- To enforce our website agreements or policies

We fully cooperate with law enforcement agencies in identifying those who use our services for illegal activities. We reserve the right to report to law enforcement agencies on any activities that we in good faith believe to be unlawful.

We may also transfer any data we collect in connection with a corporate change such as a merger, our acquisition by another company, or a partial or total sale of our assets (including as part of a bankruptcy proceeding).

California Shine the Light Law: California Civil Code Section 1798.83 permits users who are California residents to opt out of a company sharing their personally identifiable information with third parties for direct marketing purposes or to obtain from us once a year, free of charge, a list of third parties to whom we have disclosed personal information (if any) for direct marketing purposes in the preceding calendar year. 7. MINOR'S PRIVACY

Children's privacy

We also use cookies to improve the performance of our advertising on other websites. 11. US STATE PRIVACY RIGHTS

This Section applies if you are subject to the "California Consumer Privacy Act" ("CCPA") or other US state statutes relating to the rights of individuals regarding the processing of personal information (collectively "State Privacy Laws").

Data Collection

Our Services collect information that identifies, relates to, describes, references, is capable of being associated with, or could reasonably be linked, directly or indirectly, with a particular consumer or device ("personal information"). In particular, the Site collects or may have collected in the last twelve (12) months the categories of personal information as described in Section 2 above.

Use of Personal Information

We may use or disclose the personal information we collect for one or more of the business

We share your personal information with the categories of third parties listed in Section 6 above.

In the preceding twelve (12) months, we have disclosed the following categories of personal information for a business purpose:

- Identifiers
- California Customer Records personal information categories Internet or other similar network activity

We do not sell personal information. In the event that we do sell any personal information, we will update this Privacy Policy to list the categories of consumers' personal information sold.

Your Rights and Choices

Certain US state privacy laws provide residents with specific rights regarding their personal information. This section describes your rights and explains how to exercise those rights.

Right to Access Specific Information and Data Portability Right
